Annual General Meeting 2020 – Poll Results

At the Annual General Meeting of Hysan Development Company Limited (the "Company") held on 13 May 2020 (the "AGM"), a poll was demanded by the Chairman for voting on all the proposed resolutions as set out in the Notice of AGM dated 31 March 2020.

As at the date of the AGM, the total number of issued shares entitling the holders to attend and vote for or against all resolutions is 1,041,900,891. There was no restriction on shareholders to cast votes on the proposed resolutions at the AGM.

All resolutions were approved by shareholders and the poll results were as follows:

As more than 50% of the votes were cast in favour of each of the above resolutions, all the above resolutions were duly passed as ordinary resolutions.
